

**MEMPHIS SHELBY SOCCER FEDERATION (“MSSF”)
SPRING 2011 SEASON**

This online registration and \$125 performance bond for all teams U11 and above must be received by **January 11, 2011**.

This online registration and \$75 performance bond for all teams U9 and U10 must be received by **January 11, 2011**.

Teams that posted bonds in the Fall season can carry them to Spring season. Clubs that post performance bonds for their teams do not need any additional performance bond.

The Spring 2011 Season will start the week of **February 21, 2011 and end the week of May 23, 2011**.

Application process and fee structure:

1. Registration form (please fill out all information online to speed the administrative process)
2. Fees for MSSF League Play will be due at schedule pick-up.
 - a. MSSF Player Fees: \$9.00 per player for MSSF registration fee. Make check payable to “MSSF”.
 - b. MRSC Field Use Fee: \$75.00 per player for Mike Rose Soccer Complex field use fees. Make check payable to “O S Memphis”. For club’s without a Tennessee Exempt status, this fee is \$81.94 per player.
 - c. Each time a team adds a player to their roster, the team will owe an additional \$84 or \$90.94 fee for that player.
 - d. MSSF Team Fees: \$125.00 per team Performance Bond (*mail with registration form*) (non-refundable if team drops)

Each Association will be sent a list of teams and the brackets the team will play in by January 25, 2011 as determined by the club coaching directors and if all registrations are received no later than January 11, 2011.

Please read the “MSSF Rules of Competition” carefully.

The coach, assistant coach and team managers are responsible for knowing these rules.

If you have any scheduling requests, please note them on your registration form. If known, list dates your team cannot play, including any religious holidays, school holidays, and tournaments. Honored requests may not be possible in every case, but dates will be given consideration.

Please note the **fee for rescheduling games is \$50.00 per team per game**. The only reason to reschedule a game is a church or school event scheduled after February 23, 2009 that leaves your team with less than 7 players. Any other game not played will be considered a forfeit and the bond must be replaced. There are no cancelled games by teams. MSSF will only cancel games due to weather or field problems; however, the referees will determine playability after 4:00 PM daily.

Please bring the following:

1. One (1) copy of your up-to-date approved TS roster or US Club roster with jersey number by the player’s name
2. Player cards (laminated)
3. A copy of each player’s birth certificate
4. A copy of each player’s medical release form
5. The sheet that team staff and parents have signed stating they will abide by the MSSF “Rules of Competition” (form enclosed)

(If you do not have your TS roster from the state office, TS will fax to MSSF a list of all teams whose information and payment has been received. MSSF will use this list to approve the copies of the roster mailed to TS.)
